Some businesses fall between the cracks that are solely dependent on the hospitality industry but don't fulfil the criteria, could fit the discretionary grant scheme, but not enough money to go round.

Butlins normally have 8,000 guests on site, with current proposals they will have a maximum of 2,000. There is a need to appoint additional staff to deal with social distancing but businesses can't have full cohort of visitors

Businesses haven't been investing in Capital build so construction businesses have suffered also - economic productivity is going to be poor.

Apprenticeships are suffering as businesses aren't able to open

Track and Trace system could be major issue - if staffs have to isolate, need to split into teams, but there is no grants to cover the costs.

Members need to provide ongoing evidence / issues log through to the GLLEP to feed into Government asks - what are the 4/5 key asks specifically around coastal and towns - Lincolnshire specific
