## NATIONAL NEWS



#### NATIONAL FOOD STRATEGY PUBLISHED

The final report from the National Food Strategy review was published on 15<sup>th</sup> July and launched with industry and stakeholders in an event hosted by the report's author, Henry Dimbleby, on 21<sup>st</sup> July. The report concluded that the food system of the future must meet four core goals:

- Make us well instead of sick.
- Be resilient enough to withstand global shocks.
- Help to restore nature and halt climate change so that we hand on a healthier planet to our children.
- Meet the standards the public expect, on health, environment, and animal welfare.

The Greater Lincolnshire LEP and UK Food Valley team welcomes the publication of the report, the first of its kind in

over 70 years, as a first step towards recognising how important food is to our national economy, wellbeing and health. It is expected that the report will lead to a Food Bill by early 2022.

The UK Food Valley particularly welcomes recommendations which support increased consumption of naturally good for you foods such as fresh fruit and vegetables, defining minimum standards for food imported into the UK, addressing climate change and increasing investment in food chain innovation. All of these align with the key priorities for the food chain set out by the Greater Lincolnshire Food Board.



### Fishing Minister Victoria Prentis visits Seafood Cluster

On 1st July 2021 DEFRA Fisheries Minister, Victoria Prentis MP, visited the Grimsby Seafood Cluster to meet seafood businesses and participate in a Q&A session with Grimsby based processors of all types of fish and seafood.

Together with Great Grimsby MP, Lia Nici (pictured with the Minister), the Minister toured Flatfish Limited with CEO of the Seafish Industry Authority, Marcus Coleman. They also visited Young's Seafood to meet Simon Smith, CEO and Andy Rutherford, CFO

At Flatfish the Minister heard about their plans to make a £5m investment to expand production to process more UK caught fish. Flatfish which is over 40 years old now has a 138 person team and is part of the Nissui Corporation from Japan, which also owns Caistor Seafoods in Grimsby and recently acquired Three Oceans in Hull, making it a significant player in the Humber seafood sector with a total of 3 seafood brands and 400 staff.

After also hearing about the 400 jobs Young's are creating following their acquisition by Canadian Sofina group in spring 2021, a virtual round table Q&A took place with the industry.

Facilitated by Cluster Director, Simon Dwyer, the Minister listened to the fish sector's experiences post-Brexit with exports to the EU and Northern Ireland and import concerns for fresh fish from Norway and Iceland post-1st October, following new import rule changes. Patrick Salmon of Alfred Enderby also talked to the Minister about traditional smoked fish Geographical Indicator (GI) status for Smoked Haddock and the importance of promoting the Town's fish products so that more consumers eat fish from Grimsby.

The Minister commented that she is confident that Grimsby is well placed to exploit the benefits of a growing local economy with a specialism in seafood.

Whilst in the area, the Minister also visited the new Border Control Post (BCP) which is being constructed at Immingham to facilitate the inspections needed for cross border trade as part of a national programme to increase the number of BCPs.



## Universities Minister Opens Lincolnshire Institute of Technology (IoT)

Universities Minister, Michelle Donelan, visited the University of Lincoln's National Centre for Food Manufacturing (NCFM) to launch the Lincolnshire Institute of Technology (IoT) on 8<sup>th</sup> July.

The visit was one of several high-profile events arranged by the Department of Education to celebrate the national launch of the Institutes of Technologies. The Minister was joined by Karl McCartney, MP for Lincoln.

The Lincolnshire Institute of Technology is a unique collaboration between the University of Lincoln, employers and Colleges across Greater Lincolnshire, which has enjoyed £13 million of investment to create state-of-the-art facilities to meet the higher-level scientific and technical skills needs of Lincolnshire's key sectors, of which the Agri-food sector is clearly a priority. In parallel, new courses are being designed with employers to develop essential skills and provide the experience needed by over 3,000 students to access a range of high-quality technical careers with local employers.

Investment from the IoT and the Greater Lincolnshire Local Enterprise Partnership will see a new £2.4 million Digital Food Manufacturing Technologies Centre established on the South Lincolnshire Food Enterprise Zone to complement the £7million investment in the flagship Centre of Excellence in Agri-food Technologies which has recently opened.

During the visit the Minister met staff and students, employers and representatives from the Lincolnshire IoT, Greater Lincolnshire Local Enterprise Partnership, Lincolnshire County Council, South Holland District and Boston Borough Councils as she toured the Centre of Excellence and the Food Automation, Robotics and Process Technologies Research Centre.

The Minister was introduced to representatives from OAL and Bakkavor, the IoT's Anchor Employers. Samantha Norman, Director of OAL said: "As we move into an increasingly digital world, the food and drink industry is having to adapt. To pioneer in this new space, companies will be looking for young people with technical skills and this great facility will provide young people with the digital skills they need to carve out a great career in the sector."

Representing employers, Sarah Louise Fairburn, Deputy Chair of Greater Lincolnshire Local Enterprise Partnership and Director of Imp & Maker, said: "Achieving carbonneutral targets across the sector is going to need major investment in skills and technology and it is great that businesses can be supported by these excellent facilities and the expertise available at the National Centre for Food Manufacturing."









## **Icelandic Ambassador visits Grimsby**



On 24th June Iceland's new Ambassador to the UK, Sturla Sigurjonsson, visited Grimsby for key meetings with the seafood processing cluster and the supply chain.

The Ambassador, pictured with Grimsby Fish Merchants Association Chairperson, Mike Woods of Jaines Seafoods, also met with Simon Dwyer of the Fish Merchants Association, and the Seafood Grimsby & Humber Alliance and their Chairperson, Simon Smith, CEO of Young's Seafood. Discussions focused on trade and the supply of both fresh and frozen Icelandic cod and haddock which arrives weekly at Grimsby's seafood processing cluster.

The Ambassador also held meetings with Associated British Ports (ABP), who are building a multi-million pound Border Control Post (BCP) at Immingham where the vast majority of Icelandic seafood is landed and Eimskip, the Icelandic shipping line that transports the seafood.

Simon Dwyer commented: "It was a pleasure to meet the Ambassador and we had some fruitful discussions about the future landscape for supplies. We're both concerned about the UK government requirement, from 1<sup>st</sup> October 2021, for Icelandic exporters of seafood, to supply Export Health Certificates (EHCs) in their original paper form when the seafood arrives in Immingham. We agreed to maintain a close dialogue with our respective government representatives on the matter."

During a fish and chip lunch the Ambassador was keen to hear about the credentials and scale of the Grimsby seafood cluster and Mike Woods presented the Ambassador with a #MadeGreatInGrimsby baseball cap. The Ambassador also had a tour of the Flatfish Limited processing facility where he was able to view the processing of Icelandic fish for Waitrose.

#### New UK Ambassador to Iceland Learns About #MADEGREATINGRIMSBY

The newly appointed British Ambassador to Iceland, Dr Bryony Matthews, visited Grimsby on 12th July 2021 to meet representatives of the #MadeGreatInGrimsby seafood and trading cluster.

Bryony was hosted by the CEO of Seafish Industry Authority, Marcus Coleman, along with Cluster Director, Simon Dwyer.

Over a working lunch with Mike Woods, Grimsby FMA Chairman, Iceland Consulate, Jonathan Goolden (both pictured with Bryony) and Ruth Carver, CEO of the Greater Lincolnshire LEP, Bryony heard at first hand about the importance of the fish import trade from Iceland into Grimsby which is then distributed throughout the UK to major retailers as well as thousands of fish and chip shops and mobile fishmongers.

Mike Woods, who recently met the Icelandic Ambassador to the UK, expressed concerns about UK government requirement of veterinary authorised Export Health Certificates (EHCs) having to be supplied by Icelandic exporters from 1st October this year. He explained that a hard copy of the document should be physically presented with the fresh fish arrivals into the UK prior to customs clearance. Mike explained this was a major challenge for senders and fish transporters. Mike commented: "It was important to meet Bryony and discuss trade links. Icelandic fresh fish imports from 1st October are a major talking point. This bureaucratic requirement is potentially a major obstacle for trade continuity, especially with fresh cod and haddock supplies. Transportation friction and associated delays could have devastating impacts on our cluster and consumers."

Bryony also toured Flatfish Limited, a major importer of Icelandic fresh fish, in whole and filleted form, and the

construction site for the new Border Control Post (BCP) adjacent to Immingham port. The BCP will be inspecting products of animal origin for human consumption from 1st January 2022 including fish and seafood from Iceland.

Bryony said "This was a great opportunity for me to better understand the various stages of the supply chain involved in getting Icelandic fish into the UK. What struck me in particular was the speed at which each stage needs to be completed and the potential scale of the impact of a delay to any part of the process. There are clearly very strong links between Grimsby and Iceland and I look forward to finding ways to further strengthen these when I start as Ambassador next month."

Bryony takes up her role based in Reykjavik in August.





### £60,000 HUB USES FOOD WASTE TO TACKLE POVERTY

The first food redistribution hub in Lincolnshire has opened, part of a pioneering project to divert surplus food to organisations fighting food poverty.

Unsold food – such as fruit and veg, bread and baked goods and chilled food – will be collected from retailers and suppliers and taken to the hub. It's then shared between organisations that can use it to support people in need, including food banks, community larders, school holiday clubs and community cafes. The hub, which is based at Vulcan Park off George Street in Lincoln, is run by charity FareShare. The £60,000 project has been funded by Lincolnshire Co-op and the Lincolnshire Community Foundation.

Initially, the food will come from 21
Lincolnshire Co-op food stores in
Lincoln and the surrounding villages,
and from Gousto, a major food
supplier with two sites in Spalding. It
will be shared between charities in
Lincoln, East Lindsey and North East
Lincolnshire who are members of
FareShare.

FareShare Midlands is working closely with FareShare Hull and Humber to encourage more organisations in those areas to sign up to a FareShare Community Food Membership. This enables groups to access food for a nominal fee, which covers operational costs.

FareShare Midlands Director Simone Connolly said: "The effects of Covid-19 have hit people hard, and by working with the food industry we want to unlock more surplus food to be shared with charities and community groups who are getting food to those who need it most."

Supermarkets, suppliers and food production and manufacturing firms are being encouraged to join the scheme, which is supported by The Lincolnshire Food Partnership. The hub aims to redistribute the equivalent of 1,200 meals to each community organisation every month. The hub – which will be called the FareShare Food Redistribution Hub – is initially a six-month pilot.

# University Enterprise Zone (UEZ) Fund Programme

The UEZ Fund Programme which ran during 2019-21 supported 71 SME food businesses with a combination of business support, technical advice, training events and a linked small grants scheme.

The final report showed that the food companies supported were overwhelmingly positive about the support provided, with many using it to expand and grow even during Covid-19. They particularly liked the fact that they could speak to staff with first hand industry experience at NCFM and that they could access a package of support in one place. One local company which benefitted from the programme was The Lincoln Distillery. The Lincoln Distillery is a family business formed in 2017 for the manufacture and sale of craft alcohol products. It was the first 'legal' distillery in Lincoln since Victorian times and is now located in a modern unit on the banks of the historic Foss Dyke Navigation at Saxilby.

Matt the distiller is passionate about the quality and marketing of the flagship product 'Lincoln Gin' as well as developing new ones. The micro distillery industry is vibrant and highly competitive. It is little appreciated that there are many aspects of the business operation which are far removed from, but inextricably linked with, the mysterious skills of distillation.

Collaborative working with the programme team at NCFM and the ongoing technical and manufacturing support were vital for business development. NCFM scientists were able to advise on

recipe development, legal requirements and testing criteria as this artisan distillery looked to develop a new range of products.

Throughout lockdown NCFM was able to advise on recipe formulation and labelling as this resourceful business turned to hand sanitiser production. Further support was given around process and equipment design as the business looked to develop. UEZ Fund Programme grant funding was utilised towards the setup of an ecommerce website and then for capital spend on production equipment. In particular, the Anton Parr Snap 41 portable alcohol meter has transformed the timeconsuming task of cutting the alcoholic strength of the distillation process to that required for bottling. A new bottle washing machine has also aided quality and speed of work. The university is keen to run similar programmes in the future and is working with the UK Food Valley team to try to secure further funding.
