Agri-Food Industry-Relevant Announcements

1. DIT and DEFRA announcement on Food Trade support

A 'bounce back' plan of trade measures for the agriculture, food and drink industry has been announced today to help support businesses that have been impacted by coronavirus. The new strategic interventions jointly announced by the Department for International Trade (DIT) and Department for Environment, Food and Rural Affairs (DEFRA) will offer immediate support to help businesses in the industry grow their trade activity overseas.

The measures introduced will support producers, manufacturers and agri-tech companies across the food supply chain, from farm to fork as follows:-

- Package of measures designed to turbo charge UK food and drink as the world recovers from coronavirus
- The plan will provide unprecedented help for SMEs and allow them to capitalise on trade agreements being negotiated by DIT with Japan, US, Australia and New Zealand
- Designed in conjunction with business and the devolved administrations, the plan will be driven jointly by DEFRA and DIT

2. EFRA Select Committee Inquiry into Food Chain Labour Supply

The Environment, Food and Rural Affairs (EFRA) Select Committee in Parliament has re-opened their inquiry into Labour in the Food Supply Chain, following its suspension due to Covid-19 in March 2020. Further details and how to respond are set out here

The inquiry asks for responses on four questions: -

- 1. What impact will the Government's proposed points-based immigration system have on labour in the food supply chain? Which sectors will be most affected by a reduced ability to recruit from abroad?
- 2. Will investment in staff retention, productivity, technology and innovation compensate for the Government not implementing an immigration route for "lower skilled workers"?
- 3. What impact has the Seasonal Workers pilot scheme had on agriculture and horticulture? What should be the future of the scheme, including whether it should cover more, or different, agricultural and horticultural sectors?
- 4. How many seasonal workers are required in agriculture and horticulture each year, and how can this demand be reasonably met from 2021?

The deadline for responses is **Friday 3rd July 2020**. The Greater Lincolnshire LEP will be making a submission to this inquiry given how important it is to our local economy, but we would also encourage businesses to respond directly if this issue directly affects you or your supply chain.

4. Guidance and exemptions for businesses at border arrivals

Advice for seasonal agricultural workers coming to England to work on farms and their employers can be found at Coming to the UK for seasonal agricultural work on English farms

<u>English border exemption guidance</u> details exemptions from new English border rules introduced due to coronavirus. The rules apply to travellers to the UK from 8 June 2020 and of note includes seasonal workers, drivers of goods vehicles or public transport, and health and care professionals and includes information on what those exempt need to show at the border to enter the UK.

5. Rural Payments Agency (RPA) Scheme

6. Coronavirus Job Retention Scheme Update

From 1 July, employers can bring back to work employees that have previously been furloughed for any amount of time and any shift pattern, while still being able to claim the Coronavirus Job Retention Scheme grant for their normal hours not worked. When claiming the grant for furloughed hours employers will need to report and claim for a minimum period of a week. Further guidance on flexible furloughing and how employers should calculate claims has been published and can be found here.

7. Companies House COVID-19 Guidance

<u>Companies House COVID-19 guidance</u> highlights plans in place to maintain services for customers and protect the welfare of employees during the coronavirus (COVID-19) outbreak. As an emergency response to coronavirus (COVID-19), a temporary online service has been developed to

upload a number of completed forms and send them to Companies House digitally. Read the guidance to find out which documents you can upload using the new service here.

8. Transport and Travel

Changes have been made to the validity of **Driver CPC cards** held by lorry, bus and coach drivers. Driver CPC card enforcement relaxation has now been revoked. Click here for details.

The above sets out some steps employers can take to help provide a safe return to work for employees on the transport network, including encouraging active travel, and travel outside peak hours.

Progress and Future Planning

Greater Lincolnshire LEP

The LEP has completed a first draft of an agri-food recovery plan which pulls together all the evidence and input you have fed in through the <u>Business Intelligence</u> platform and other channels and from which priority actions have been identified.

The document outlines the headline feedback on impacts, sets 10 priorities for industry and government, and specifies the actions we have already taken, alongside four suggested areas. More detail will follow in due course.
