## South Lincolnshire FEZ launch event March 2021

The webinar launch of the South Lincolnshire Food Enterprise Zone (FEZ) on 17<sup>th</sup> March attracted 300 participants to hear the opportunities opening at the FEZ and across the wider food cluster.

The launch highlighted the University of Lincoln receiving the keys to the brand new Centre of Excellence (below), which is the first building on the FEZ. Work is also now starting on both the Institute of Technology (IoT) which will open later in 2021 and the FEZ Hub building, due to open in early 2022. The IoT will focus on recruiting and training the next generation of food sector engineers and technicians, and the FEZ Hub will host start-up and food sector SMEs in a series of offices and workshops. #### National Report on Data Trust in the Food Chain led by University of Lincoln

The study, 'Food Data Trust: A Framework for Information Sharing', released on 26<sup>th</sup> March 2021, was produced by Internet of Food Things Network Plus and led by the University of Lincoln, to examine innovation in the burgeoning technology of 'data trusts', which have been described by technology experts as 'a glimpse into our collective future' in the secure and effective use of big data.

#### 850 Group sold to Sofina Foods

The 850 Group, which includes Greater Lincolnshire-based Youngs Seafood, Karro Food Group, and five other protein business across Europe, has been acquired by Sofina Foods of Canada. The 850 Group has sales of £2bn per year and employs 8,300 people across 23 sites. As part of the now enlarged Sofina Foods business, the new combined business will have a turnover of nearly \$6billion and 13,000 employees globally. The development of the new Softripe System has been spearheaded bv Neal Collishaw. Operations Director at Worldwide Fruit and member of the Greater Lincolnshire Food Board.

Netherlands, supplying directly to garden centres, nurseries, and retailers.

Floralinc's European operation exports raw materials from Europe to the UK for use by packers and manufacturers, utilising the Spalding Freshlinc hub for onward consolidation. With the fully accredited Border Control Post (BCP) and External Storage Facility (ESF) at the Spalding Freshlinc site, they are now working towards a BCP and ESF directly at the Floralinc site, which will be operational from July.



# Business Awards Wins for Food Cluster Companies

March has seen two local food chain companies honoured for their work in the food chain:

- Worldwide Fruit won the Lincolnshire Business of the Year Award and the Food & Farming Award at the Lincolnshire Business Awards on 24<sup>th</sup> March.
- Food chain logistics company Fowler Welch won Best Practice in Logistics for the third time at the Waste2Zero awards run by Foodservice Footprint, which recognise excellence in reducing the environmental impact of the food chain.

#### Dyson Farming Glasshouses Harvest First Crop

In late March 2021, Dyson Farming picked the first crops of fruit from their new 15-acre glasshouse unit at Carrington, near Boston. This unit supports the delivery of high-tech, sustainable farming, replacing imported strawberries. With energy from Dyson Farming's adjacent anaerobic digester, the glasshouse houses 700,000 strawberry plants and will produce 750 tonnes of strawberries each year. The University

of Lincoln worked with the Dyson team on energy and robotics systems as part of the design of this world-leading development. For more information click <u>here</u>.

#### Cropdesk launch Seasonaljobs for recruiting seasonal fresh produce workers

Cropdesk is a software company focussing on the global fresh produce industry, founded by awardwinning blueberry farmer David Trehane.

The platform SeasonalJobs was created when the pandemic took hold as a response to the high priority need for skilled seasonal workers within the fresh produce sector. The platform runs via app with a supporting website, and matches job seekers with labour users in the industry, providing employers with pre-screened, ready-to-work candidates for seasonal positions in several industries.



Seasonaljobs runs social media advertising campaigns to secure workers with exactly the right fit, focussing on industry requirements such as fitness level, experience, availability, and location.

Each employer-user, a "partner", pays a fee of £100 per candidate on acceptance of a role. This enables them to post roles that they need filling and to be able to interview and select available workers. This fee supports the ongoing development of the app functionality and UX interface. There is no cost to the job seeker.

#### Magnavale Investment in Easton, Grantham

Magnavale, which operates a range of cold storage and food chain solutions for fruit and vegetables across the Midlands, has recently announced a major investment at Easton to construct the UK's largest and most efficient Cold Storage Unit. As a new purpose-built and stand-alone store, this facility will be the largest in the UK and will also run entirely on renewable energy, providing capacity space for 96,000 pallets.

Construction of the project will create 230 jobs over 2 years, boosting the local economy during the COVID-19 recovery period. Following construction, a further 300 jobs will be created on a permanent basis to operate the facility going forward. For more information click <u>here</u>.

# NATIONAL NEWS

#### Seasonal workers to receive free Covid-19 tests on farms

Employers of seasonal agricultural workers in the edible horticulture sector are <u>urged to register</u> for free workplace testing.

#### Trade and Agriculture Commission (TAC) report

The TAC advises the Government on how to advance the interests of British farmers, food producers and consumers in future trade agreements outside the EU. It set out 22 recommendations based on a set of principles, including that the UK should aim to:

- Promote the liberalisation of trade, to positively influence innovation and productivity and price and choice for consumers
- Prioritise a thriving domestic agri-food sector supported by complementary domestic and trade policies
- Ensure that agri-food imports meet relevant UK and international standards on food safety and biosecurity

# FUNDING

#### Capital Allowance Super Deductions

The March 2021 Budget announced a new Capital Allowance Super Deduction programme which provides:

- A temporary increased tax relief for qualifying expenditure on plant and machinery incurred between 1 April 2021 and 31 March 2023.
- The relief will be 130% of the cost of the capital investment.
- The relief is only available if you run a limited company, but for these businesses will mean tax cuts of up to 25p (130% of the corporation tax rate) for every pound invested in qualifying plant and machinery.

This creates a real incentive to invest in new machinery, equipment, and systems to improve productivity and sustainability. Further details are available in the Treasury factsheet, but as with all tax please consult your accountant first <u>here</u>.

#### Farming Innovation Pathways

A new £12m fund has been launched by UKRI and DEFRA to fund farming innovations, supporting:

- Feasibility studies of 12-18 months duration and with eligible project costs of £75,000-£250,000
- Industrial research projects up to 24 months and with eligible project costs of £250,000 £750,000

The competition closes on 28 April 2021, and is for collaborative feasibility studies and industrial research projects, which target the development of innovative farm-focused technologies, systems or approaches to help improve food productivity, as well as increasing resilience and sustainability in line with net zero ambitions.

Projects must address one or more high priority areas in at least one of these four industry subsectors:

- Livestock
- Plants

- Novel food production systems
- Bioeconomy and agroforestry

## Internationalisation Fund

Match-funded grants of between £1,000 and £9,000 will be available to help SMEs investigate the potential in overseas markets. To secure a grant, businesses need to fund either 40% or 50% of the total cost, depending on business size. The fund can be used to support areas including (but not exclusively limited to):

- Market research
- IP advice
- Translation services
- International social media/SEO

- Trade fairs (where no TAP funding is available)
- Independent market visits
- Consultancy and other international commercial services

## Workplace testing programme: registration extended to 12 April for 10+ employees

The government has now made rapid home testing available for all businesses with <u>over 10 employees</u> <u>who cannot offer on-site testing</u>. Businesses must register their interest by 12 April to access free tests. Businesses can <u>sign up</u> for free COVID-19 workplace asymptomatic testing <u>here</u>.

#### Geographical transition for businesses

As of 1 April 2021, the geographical overlap between the Greater Lincolnshire LEP and the Humber LEP has been removed, and North and North East Lincolnshire will be part of the Greater Lincolnshire LEP only and no longer part of the Humber LEP.
