Industry-Relevant Updates and Announcements

1. Retail Businesses Guidance:

- Subject to being COVID-secure, from 1 June, outdoor markets and car showrooms were able to reopen, with all other retailers eligible to reopen from 15 June if the Government's five tests are met and retailers follow the COVID-19 secure guidelines.
- Updated guidance to support the reopening of the retail sector has been published, detailing the
 measures retailers should take to meet the necessary social distancing and hygiene standards and to
 become COVID-19 secure. Click here for further guidance.
- From 15 June some district councils, including South Holland, will have staff deployed into town centres to help provide reassurance and advice. More information on High Streets to follow.

2. Guidance and exemptions for businesses at border arrivals

- Advice for seasonal agricultural workers coming to England to work on farms and their employers can be found at <u>Coming to the UK for seasonal agricultural work on English farms</u>
- English border exemption guidance details exemptions from new English border rules introduced due to coronavirus. The rules will apply to travellers to the UK from 8 June 2020 and of note includes seasonal workers, drivers of goods vehicles or public transport, and health and care professionals and includes information on what those exempt need to show at the border to enter the UK.

3. Trade Credit Insurance

• Government has confirmed it will provide guarantees of up to £10 billion to Trade Credit Insurance schemes for business-to-business transactions. Visit here for more information.
