Headlines

- **Hands, Face, Space.** Keep washing your hands thoroughly, for 20 seconds. Use a face covering unless exempt. Keep two metres apart from others, or one metre plus precautions.
- **Our actions as individuals matter.** It is our own personal responsibility to make sure we each keep to the lockdown restrictions - to protect the NHS and to save lives - and keep doing the basics with hand washing, face coverings and social distancing.
- **Know where to look for help.** Information is being shared by agencies including the Lincolnshire Resilience Forum, councils and police. If you're concerned about a business premises not complying with the lockdown restrictions set out by Government, you can raise your concerns with the Public Protection Team at your local council. More rapid COVID-19 tests to be rolled out across England

600,000 lateral flow tests will be sent out this week to kick-start the significant expansion of testing, followed by weekly local allocations.

- This next stage of partnership between NHS Test and Trace and local directors of public health will enable increased testing of priority and high-risk groups in local communities on a weekly basis, and;
- The increase in asymptomatic testing will help pick up more cases, stop the spread of the virus and support communities and critical industries

Government secures 5 million doses of Moderna vaccine

Further to the Pfizer vaccine announced last week, Government has concluded negotiations with Moderna to secure access to 5 million doses of its promising coronavirus vaccine which could be delivered to the UK from Spring 2021, if approved by the medicines regulator. This deal increases the total number of doses secured by the UK to 355 million, as part of government's strategy to build a diverse portfolio of promising vaccines

Coronavirus Bounce Back Loan: The Bounce Back Loan Scheme enables smaller businesses to access finance more quickly during the coronavirus outbreak. New options are available to top up existing loans, extend the loan period, make interest-only repayments, or pause repayments. The scheme is open to applications until 31 January 2021. If you already have a Bounce Back Loan but borrowed less than you were entitled to, you can top up your existing loan to your maximum amount. You must request the top-up by 31 January 2021. How HMRC will continue to support customers and the economy: HMRC's work has been at the centre of the government's response to COVID-19. HMRC have [issued a briefing](#) on how they will work with customers and stakeholders over the coming months, while COVID-19 continues to impact the country.

Boost for restaurants, pubs and cafes as Jenrick extends takeaway services. Restaurants, pubs and cafes will get automatic freedoms to provide takeaway services for another year.

- Government extends temporary freedom for pubs, restaurants and cafes to provide food takeaways by another year
- Freedoms enabling outdoor markets also extended in further boost for hospitality sector, enabling them to plan ahead for the economic recovery with certainty
- New protections for cultural venues, measures enabling emergency building such as Nightingale hospitals extended, and space standards introduced for new homes built through 'permitted development'
