Headlines

Targeted Testing

Local priorities for targeted testing are:-

- Geographical areas or communities of concern - invite the people in these areas to be tested even if they are without symptoms
- High consequence settings - whole setting symptomatic testing in children's homes, residential schools, critical local government services, voluntary sector frontline services, food manufacturing and key retail
- Domiciliary care - for all residents being discharged from hospital settings into the care or domiciliary care, supported housing, community supported living etc. This will also include access to testing for people in receipt of personal budgets or direct payments and their carers.
- Outbreak management - rapid deployment of testing, especially in settings where this is not currently available for asymptomatic 'populations' who are part of this group.

Vaccination Update

Key messaging:

- The roll out of additional vaccination centres is being handled at a national and regional level and more information will follow once the final list of those sites is available.
- Local Authorities are working with the NHS to support the delivery of the Covid-19 vaccination programme.
- This programme is being rolled out in phases. Those aged 80 years old or over, should wait for an invitation to be called for vaccination and there is no need for patients to contact their practice. No one should visit their practice for a vaccination without an appointment.
- The NHS is working on the locations for these additional sites and GP surgeries across the country are joining to support hospitals in the delivery of the jab, followed by larger vaccination centres in key locations nationwide. A full list of these sites will be issued as soon as available.

Self-isolation period reduced

A change to the self-isolation period from 14 to 10 days has been announced. This change applies in England, Scotland and Northern Ireland and began on Monday 14 December.

Business Lincolnshire Covid-19 Funding

Test and Trace Payment Scheme

- Individuals can now apply for a payment of £500 under the Test and Trace Payment Support Scheme provided if they have been notified by contact tracers or the app to self-isolate and that they meet the eligibility criteria.

- People in Lincolnshire can apply for the payment through their district council. To find your local council and their application page please visit [here](#).
- To complete applications individuals will need an 8-digital NHS Test and Trace Account ID which will be provided for anyone testing positive for coronavirus or told by contract tracers to self-isolate.
- An Account ID must be requested during the isolation period and claims can be made up until 14 days after a self-isolation period has ended.

Temporary relaxation of drivers' hours for delivery of essential items to retailers

In response to pressures on local and national supply chains, the Department for Transport has introduced a temporary and limited urgent relaxation of the enforcement of EU drivers' hours rules in England, Scotland and Wales. This temporary relaxation will apply from 12:01am on 10 December 2020 and will run until 11:59pm on 30 December 2020. Importing and Exporting

- NEW: The DIT Export Control Joint Unit will be making changes to SPIRE (the electronic strategic export licence database) in preparation for the end of the transition period and will not be available on 31 December 2020. Read [Notice to Exporters 2020/19](#) to find out more. See also some additional information you will need to supply when making applications, so that ECJU can issue the correct licence from 1 January 2021. Please ensure you have registered for the [Open General Export Licence \(exports of dual-use items to EU member states\)](#) if you export dual-use items to the EU. From 1 January 2021, without this licence, your goods could be stopped by Customs.

Level 3 Qualifications & Skills Bootcamps

The Department for Education has announced Level 3 qualifications and update on Skills Bootcamps.

The [Lifetime Skills Guarantee](#) aims to transform the adult education system. From April 2021, adults without A Levels (or equivalent) will be eligible to study for a [fully-funded Level 3 qualification](#). There are nearly 400 courses available in sectors from engineering and construction, to conservation, child development or business and accounting.

Additionally, new [Skills Bootcamps](#) offer flexible courses of just 12-16 weeks, giving adults aged 19+, the opportunity to build sector-specific skills and fast-track to an interview with a local employer. These short digital and technical courses will enable employers to play a leading role in the skills system and fill skills gaps at local levels.
