## British public urged to assist in vaccine roll out

The public has a vital part to play in the rollout of the UK COVID-19 vaccines and are urged to join the national effort by helping family and friends aged 80 and over to get their life-saving jabs and to commit to **3 pledges** to support the roll out of COVID-19 vaccines. Further info here.

- 1. Help out those aged 80 and over by supporting friends, family and loved ones with their appointments, as well as volunteering to help those in the community
- 2. Join up sign up to clinical trials for Covid-19 vaccines and treatments
- 3. Stay informed keep up to date with accurate and trusted NHS advice and make sure to share facts with friends and family

## Lincolnshire NHS leading the way with first large vaccination centre

The Covid vaccination programme in Lincolnshire continues to successfully roll out, meaning the protection of the county's residents through vaccination is successfully continuing. Specifically, Lincolnshire has been:

- amongst the first in the country to start vaccinating on 8<sup>th</sup> December through our first hospital hub at Lincoln County Hospital
- amongst the first to start vaccinating through our GP-led primary care network model, with fifteen centres in operation
- amongst the first in the country to be offering the new AstraZeneca vaccination, from our latest hospital hub at Pilgrim Hospital in Boston

Lincolnshire was amongst the first in the country to open a large vaccination centre at the Princess Royal Sports Arena, Boston on 18<sup>th</sup> January 2021. The site will initially be the first and only one of its kind across the entire (East and West) Midlands area, meaning the NHS can offer many more local people their appointment sooner. The large vaccination sites, will initially be vaccinating people in the key priority groups, starting with local residents over 80 who live within 45 minutes of the site. These people will be contacted and offered the centre as a choice for their vaccination appointment and local people are asked not to contact the NHS. ## Covid-19 vaccines rolled out to people aged 70 years and over

People aged 70 and over and the clinically extremely vulnerable to begin receiving invitations for vaccinations from 18<sup>th</sup> January enabling the NHS to further accelerate vaccinations of people most at risk. The priority remains to vaccinate top 2 cohorts first, while over 3.8 million people have received their first vaccine dose in the UK.Further info here.

## **Business and Economic Updates**

#### **Lockdown Support Schemes**

In relation to schemes for businesses that are required to close because of government policy, all local authorities are now making automated payments to businesses that they already have on their database. If you are a business which has had to close and have not yet made contact with your local authority, you should do so as a matter of urgency to ensure that the local authority has contact information.

The Government recently announced a top up payment of up to £9,000 for businesses closed due to the wave 3 lockdown. The guidance and funding for this scheme is not yet available but local authorities are working hard to ensure that they can make these payments to eligible businesses as soon as they are able to. It is expected that these payments will be made automatically to those businesses which are closed and who local authorities are already aware of, and they will be in contact with these businesses in due course. If your business has had to close and not yet made contact with your local authority, please do so as above.

#### **Business Grants**

- One-off top up grants for retail, hospitality and leisure businesses worth up to £9,000 per property to help businesses through to the Spring
- £594 million discretionary fund also made available to support other impacted businesses

The one-off top-ups will be granted to closed businesses as follows:

- £4,000 for businesses with a rateable value of £15,000 or under
- £6,000 for businesses with a rateable value between £15,000 and £51,000
- £9,000 for businesses with a rateable value of over £51,000

## **Hospitality Minister Debate**

This was triggered by petitions on this issue exceeding the 100,000 mark and was well attended with very strong and knowledgeable contributions by a range of MPs. The call for a Hospitality Minister was responded to by the Minister for Small Business, Consumers and Labour Markets, Paul Scully, who acknowledged and emphasised the importance of hospitality to the UK economy and local communities. He undertook to continue to work with the sector to support it through the immediate crisis and then build back stronger, but stopped short of agreeing with the need for a Hospitality Minister.

The debate ended with Catherine McKinnell MP, who introduced the petition, thanking the Minister for his response but urging him to take the idea of creating the position of Hospitality Minister to the Prime Minister as something that it is in the Government's interest to create.

# Manufacturing firms focus on new products, building resilience and agility to counter risks over fears for new relationship with EU

Fears over the impact of the UK's new trading relationship with the EU and the attractiveness of the UK for both investment and talent are clouding the outlook for manufacturers as they enter 2021, according to a major survey published today by Make UK and PwC.

However, despite this, more companies believe the opportunities outweigh the risks for the ir businesses given significant investments in boosting productivity and agility, while manufacturers are also more confident about the prospects for their own companies than they are for either the global or UK economies.

The 2021 Make UK/PwC Executive survey shows that a third of companies believe the investment prospects for UK businesses will decrease having left the EU with just 18% of companies believing they

will increase. In addition, just over a quarter of companies (26%) believe exports to the EU will fall with just 16% believing they will increase. A third also believe the UK's ability to attract international talent will decrease with just 11% believing the UK will be a more attractive destination outside the EU. According to Make UK this potentially puts at risk the ambition of the Government's new immigration system which is specifically designed to encourage the best talent to come to the UK.

The survey also shows that customs delays are seen as the biggest risk to companies (47%) while concerns over national and local lockdowns were the second biggest risk (46%). Furthermore, increased costs of regulation is reported as the biggest risk by just under forty per cent (39%) while over one in 10 companies (14%) also believe a relocation of a major customer out of the UK is their biggest risk.

## **EU Transition**

## Act now to keep your business moving in 2021

The Business Minister has urged businesses who have not yet taken steps to prepare for the UK's new start since we left the EU's Customs Union and single Market, to take action now. In his message to business, the Minister highlights six key actions that many firms need to take. These 6 key actions should act as a guide for every business affected by the new rules, with more detailed, personalised advice available through the checker tool on gov.uk/transition.

- 1. Goods if you import or export goods to the EU, you must get an <u>EORI number</u>, make customs declarations or employ an agent to do them for you, check if your goods require extra papers (like plant or animal products) and speak to the EU business you're trading with to make sure they're completing the right EU paperwork. There are also special rules that apply to Northern Ireland. Hauliers must obtain a <u>Kent Access Permit</u> and have a negative COVID test before they head to port in Kent
- 2. **Services** if you deliver services to the EU, you must check whether your <u>professional</u> qualification is recognised by the appropriate EU regulator
- 3. **People** if you need to hire skilled staff from the EU, you must apply to become a licensed sponsor
- 4. **Travel** if you need to travel to the EU for business, you must check whether you need a <u>visa or</u> work permit
- 5. **Data** if your goods are protected by <a href="Intellectual Property">Intellectual Property (IP)</a>, you will need to check the new rules for parallel exporting IP protected goods from the UK to the EU, Norway, Iceland and Liechtenstein. You risk infringing on IP rights if you do not follow the new rules
- 6. **Accounting and reporting** if your business has a presence in the EU you may need to change how you undertake <u>accounting and reporting</u> to ensure compliance with the relevant requirements


## Keep your business moving: New video explainers on doing business with Europe
