Coronavirus Headlines

COVID-19 vaccines have prevented 10,400 deaths in older adults

PHE analysis suggests the UK COVID-19 vaccination programme has so far prevented thousands of deaths in those aged 60 and above.

Public Health England (PHE) has indicated that the Covid-19 vaccination <u>programme</u> prevented 10,400 deaths of older adults in England up to the end of March, an additional 4,300 since the previous update. Further information can be found <u>here</u>.

People urged to keep appointments for second COVID-19 vaccinations in April

People in Lincolnshire who are booked in during April to have their second COVID-19 vaccination are being urged to keep their appointments.

"Our message to people is clear - having two vaccinations gives the best possible protection against covid. So please make sure you attend for your second vaccination when called, it really is vitally important," said Dr Baker, GP and South West Lincolnshire Locality Lead, NHS Lincolnshire CCG.

This message is supported by Lincolnshire's Public Health team, as Andy Fox, Assistant Director of Public Health, added: "We should all aim to maximise the protection we get against covid, and crucially the best way to do this is by having two doses of the vaccine. It is also very important that we all continue to follow the guidance around social distancing - hands, face, space, fresh air."

People aged 45 and over now able to book their covid-19 vaccination

People aged 45 and over are now also able to book their COVID-19 vaccination. Appointments to have the vaccination at one of Lincolnshire's Large Vaccination Centres - Boston PRSA or the Lincolnshire Showground - can be made on the national booking website www.nhs.uk/covid-vaccination or by calling 119 free of charge between 7am and 11pm, seven days a week.

NHS Patient Transport Service Review & survey

The NHS in Lincolnshire is reviewing its existing patient transport service and is seeking feedback to discover what is working well, alongside areas of improvement.

Non-Emergency Patient Transport Services (NEPTS) provides NHS-funded transport for eligible people taking them from home to a care provider (and back again) for planned outpatient appointments and treatment.

Business and Economic Updates

ONS Economic Indicators

The Office for National Statistics has released a <u>report</u> on economic indicators used to measure the performance of the UK economy, noting two positive indicators for the hospitality sector.

The number of seated diner reservations for 12 April 2021 is estimated to be at 79% of the level seen on the equivalent Monday of 2019. This appears to indicate the demand for people to dine out post-lockdown.

Another finding suggests online job adverts on 9 April 2021 equalled their February 2020 average level to become the highest level seen since 6 March 2020. This was partly driven by an increase to the "catering and hospitality" category, which also reached its highest level since March 2020.
