The Department for Business, Energy and Industrial Strategy (BEIS) is encouraging business owners and shop workers to take photos in front of their 'open' sign next week and post these on their social media channels as part of the #OpenForBusiness Campaign. #### 2. New support for high streets

### 4. Office for Produce Safety and Standards (OPSS) Guidance for business and local authorities

### 5. Self-Employment Income Support Scheme

If you're self-employed or a member of a partnership and have been adversely affected by coronavirus (COVID-19) find out if you can claim a grant through the Self Employment Income Support Scheme.

### 6. Coronavirus Job Retention Scheme Update

As the Chancellor announced previously, from 1 July, employers can bring back to work employees that have previously been furloughed for any amount of time and any shift pattern, while still being able to claim the Coronavirus Job Retention Scheme grant for their normal hours not worked. When claiming the grant for furloughed hours employers will need to report and claim for a minimum period of a week.
